While focusing on Turkey, the book presents analytical tools applicable under rising authoritarianisms and conservatism worldwide.

These stereotypical attitudes are explored to understand Paul's paternal relations (2:10-12) with his Thessalonian children and in resolving sexual immorality (4:3-8) and the refusal by some brothers to work (4:9-12; 5:12-15). This study has implications for the structure of early Christian communities.
